COMAR 08.01.06.06 (G) Reads as follows:

Except for use in carrying out its governmental functions, the custodian shall not disclose, and shall deny inspection or copying of, any part of a public record that contains sociological information relating to an individual. For purpose of this section, sociological information means:

- 1. Social Security number;
- 2. Personal address;
- 3. Personal telephone number;
- 4. Personal e-mail address;
- 5. Medical history;
- 6. Educational history;
- 7. Work history;
- 8. Military service;
- 9. Financial information;
- 10. Religious preference, membership, and attendance;
- 11. Personal relationships; beliefs, and values;
- 12. Genealogical charts; and
- 13. Family history.
