

Guide to 2014 Commercial Striped Bass Changes

In 2014 the Striped Bass fishery will undergo many changes. Based on your current Striped Bass permit(s), you likely fit into one of the three listed categories below; refer to your section of this letter for details of relevant changes. - 1. Atlantic Permit(s) Holder
- 2. Chesapeake Bay: Single Permit Holder (Pound Net/Haul Seine/Hook & Line/Gill Net)
- 3. Chesapeake Bay: Multiple Permit Holder (Pound Net/Gill Net)

1: Atlantic Permit Holders (no change)

• Everything is operating as it has in the past. Each Atlantic permit will be given a similar allocation. Changes to this process only apply to the Chesapeake Bay fishery.

2: Chesapeake Bay- Single Permit Holder (PN/HS/HL/GN) IMPORTANT CHANGES!

- <u>Permit Renewal (August 2013)</u>: In order to participate in the 2014 fishery, you need to renew your permit as you have in the past.
- <u>CP/ITQ Fishery Selection:</u>
 - PN and HS → Opted into the ITQ Fishery (historically equal allocation distribution)
 - GN/HL \rightarrow Choose to fish the Common Pool or ITQ (see *Fishery Cheat Sheet*)
- <u>Transfer Process:</u>
 - Each fishery has unique pre-season (August through September) and in-season transfer options. Please refer to the *Transfer Options* handout for more information.

3: Chesapeake Bay- Multiple Permit Holder (PN/GN) IMPORTANT CHANGES!

- <u>Permit Renewal (August 2013)</u>: In order to participate in the 2014 fishery, **you only need to renew one of your permits**. However, if you intend to lease or transfer additional permits, those will also need to be renewed.
- <u>CP/ITQ Fishery Selection:</u>
 - PN → Opted into the ITQ Fishery (historical equal allocation distribution)
 - GN \rightarrow Choose to fish the Common Pool or ITQ (see *Fishery Cheat Sheet*)
 - Own PN *and* GN permits? \rightarrow You are opted into the ITQ Fishery.
- <u>Transfer Process:</u>
