Minutes of the Garrett County Forest Conservancy District Board Meeting March 11, 2024

Call To Order:

The Garrett County Forestry Board met at 9:00 a.m. on Monday March 11, 2024 at Mt. Nebo. Those Board members in attendance either in person or virtually were: Mike Minnick, Mike Kozier, Mike Ferguson, Will Williams, Larry Tichnell, Ken Fisher, Bill Aiken, Bill Buckel, Derek Buckel, John Bambacus, Fred Eggleston, Siera Wigfield and Melissa Nash. Guest in attendance was Don Sebold.

The agenda was approved with motion by Fred and 2nd by Mike K.

Minutes of the previous meeting were approved following a motion by Ken and 2nd by Will.

Bill B. read the treasurer's report. A deposit of the county funding was made. Expenses included calendar printing. Bill and Melissa worked on getting set up for the electronic transfer of MUCFC funds for the 3 recently approved grants, but money has not been received yet.

OLD BUSINESS:

Big Tree Calendar

250 calendars were ordered and are expected to arrive by the end of March. Will suggested having an envelope or rain sleeve if we are selling calendars at any events.

DCL Water Level Legislation

No recent legislative updates have been received. A hearing was held on this bill and the public was largely left out of its development. There have been concerns raised from multiple user groups.

Watershed Update

Siera reported they had 2 good candidates and are working on scheduling interviews for the watershed coordinator position. She is hoping to have someone on board by summer. The MOU has now been signed by MDE, DNR and the county.

Dan McCrary is working on a stream assessment for tributaries to Arrowhead Cove.

The 100th anniversary of Deep Creek Lake is being planned for 2025. This would be a good opportunity to promote the management plan.

Trail Planning Grant

Several Board members expressed concerns with offering blanket support to trail planning, given lack of public involvement on past projects so a letter of support was not provided. Siera envisions a county plan that looks at trail connectivity within the region and takes into account various types of user groups (walk, bike, ORV, water, etc). She is looking into multiple sources of funding for trail planning.

Yough River Advisory

Don advised the hearing will begin April 2nd at 9am at the courthouse. There are still many questions and concerns over the bridge project.

He further advised that any trails being planned within the corridor should be presented to the advisory board.

The advisory board will meet 3/13 at 9am in the Commissioners meeting room.

Smokey Reading Challenge

Two kickoff events with Smokey Bear appearances have been scheduled for 3/27 at the Grantsville Library and 4/2 at the Oakland Library. Set up of the window will be 4/2 prior to the program. Melissa will be picking up the prize books from the Book Market.

NEW BUSINESS:

NRCC

We have 3 applicants already, but some are missing recommendation letters. Melissa or Mike M. will reach out to the students and ask they get their applications completed ASAP. A discussion was held on funding. Siera made a motion that we fully fund up to 3 students this year. If more applications come in, we will look at other sources of funding or put students on an interest list for 2025. Will 2nd and the motion passed.

The urban forestry camp has been approved for this year, but no further information was available.

We still have time to put together items for Gabrielle's gift basket.

Another blow was delivered to local wood markets with the shutdown of AWP recently. Several local loggers are still owed money by the company.

Native Plant Festival

We will raffle off a few trees again and Bill A offered to donate a mushroom log. We will also have the Big Tree calendars to sell. The event is May 11 at New Germany State Park.

Transition Fair
