EXECUTIVE SUMMARY

The Allegany County Land Preservation, Parks and Recreation Plan guides the future use of funds made available to the citizens of the County by the State of Maryland and the Federal government for the preservation of the open space and provision of recreational opportunities. By enumerating the goals, plans and policies guiding the use of those funds, the County ensures that it makes successful investments in the population's quality of life. The Plan is scheduled to be adopted by the County Commissioners in the summer months of 2022.

Allegany County employs strong public/private partnerships with various civic groups and local sponsors to operate and maintain its parks. The seven municipalities within the County own and manage recreation facilities within their boundaries. Although the County has met the State of Maryland's goal of having 30 acres of public recreation land per 1,000 persons, it should continue to the acquisition of property for park development in various small communities that are underserved.

The County continues to develop the Allegany County Fairgrounds, a regional recreation area, to serve citizens of the Tri-State area. Numerous annual events and recreational opportunities are provided by the Fairgrounds. Open Space funding continues to be one of the major funding sources for the County to update and expand recreational areas within Allegany County.

Together, State, Federal and locally owned parklands occupy almost a third of the County's land area, amounting to an acre of parkland per County resident. Allegany County has the 12th largest land mass in Maryland, and is ranked 16th in population, but has the second largest area owned by the Maryland Department of Natural Resources. Understandably, protecting Open Space in Allegany County has not garnered the sense of urgency as it has in communities elsewhere in the State. The County does, however, encourage the acquisition of properties adjacent to public lands, or properties situated in enclaves of public property, particularly when those areas contain steep slopes or habitats for endangered species. The County participates in and encourages Agricultural Land Preservation and the Rural Legacy Conservation programs sponsored by the State of Maryland. Explicit protection of agricultural land use, known as the "right-to-farm" policy, is written into the County Zoning Code.

Transportation systems, mining, and industry are sources of Allegany County's urban development. However, due to the limitation imposed by the County's topography and soil conditions, the County does not have as rich of an agricultural heritage as neighboring Garrett County.




Figure 3 Public Parklands


GENERAL GEOGRAPHIC INFORMATION

Allegany County lies in Western Maryland, and is bound on the west by Garrett County, Maryland; on the east by Washington County, Maryland; on the north by Somerset, Bedford, and Fulton Counties, Pennsylvania; and on the south by Mineral, Hampshire, and Morgan Counties, West Virginia.

The County's boundaries are the Chisholm line on the west, the Mason Dixon line on the north, Sideling Hill Creek on the east, and the Potomac River on the south. The County is about 40 miles long from east to west and varies from 5 to 20 miles wide from north to south, comprising an area of 426 square miles or 271,793 acres.

Allegany County lies in the Appalachian Mountains, partly in the Ridge and Valley Physiographic Province, and partly in the Allegheny Mountains Physiographic Province. The County lies entirely within the Potomac River Basin and the Chesapeake Bay Watershed.

The County is approximately 120 miles southeast of Pittsburgh, PA; 140 miles northwest of Baltimore, MD, and Washington, D.C.; and 320 miles southwest of New York City. County location is referenced below in Map I Allegany County, Maryland Location.

POPULATION& DEMOGRAPHIC INFORMATION

As a result of decreased employment in the mining and transportation industries, Allegany County experienced a decline in population starting in the 1950s. The population stabilized through the 1970s due to increased employment in manufacturing. However, by the mid-1980s nearly all the large-scale factories in the County were closed or operating with a reduced workforce because of new technologies, lower production costs, and a higher demand for service-oriented jobs. Today, Allegany County's population shows signs of stabilization and is even projected to begin increasing in the decades to come, which can be seen in Figure 5. This increase can be attributed to a revitalized transportation network, increased demand for energy-related jobs, and a focus on retaining and expanding employment in the Health and Social Services industries where the County excels.

POPULATION OVER VIEW




Figure 4 Population by Decade (1950-2020) Source: Maryland Department of Planning




Figure 5 Total Population Projection Source: Maryland Department of Planning

The first decade in the County's history for which population loss was recorded was the 1950s. This loss was a result of serious economic difficulties throughout the Appalachian Region, which lost 1.5 million people between 1950 and 1960. As illustrated in Figure 4 Population by Decade (1950-2020), population loss due to economic difficulties and shifts in population continued throughout the subsequent decades until the population stabilized in 2000 and then slightly decreased in 2020. Figure 5 depicts the projected population of Allegany County until 2040.




Figure 6 Group Quarters Population by Decade (1970-2020) Source: Maryland Department of Planning

The rise in group quarters populations is a contributing factor to Allegany County's population stabilization. Group quarters are places where people (typically unrelated) live or stay in group living arrangements which are owned or managed by an entity or organization. Group quarters include places such as college residence halls, residential treatment centers, skilled nursing facilities, group homes, military barracks, correctional facilities, and workers' dormitories. Figure 6 below depicts the growth in group quarters population from 1970-2020.

Table I provides population projection data by age group. Overall, the population trend within Allegany County is positive. However, the various age groups differ from this trend. For example, age groups 0-4 and 5-19 are projected to decline over the next few decades. This may be a result of people having less children and families becoming smaller. On the other hand, the Baby Boomer generation (born from 1946 to 1964) is showing an increase only up until 2040, and then that generation's population is expected to decrease. Overall, the County's population is aging - a point, which is solidified by a decreasing youth population, and a middle-aged (20-44) population which is expected to increase. To further emphasize the County's aging population, Table 2 depicts the projected population of those aged 65 years or older as a percentage of the County's total population.

- To prevent the denial of, reduction in, or significant delay in the receipt of benefits by minority and low-income populations.





Figure 7 Demographic Profile of Allegany County (Source: American Community Survey (5-year) Estimates)

Figure 7 shows nearly a fifth of the population of Allegany County have a disability and or are below the poverty level. Please note the categories of race, disabilities, and income level are not mutually exclusive, a person may fall under more than one of these categories.

Allegany County's minority population is centered in the urbanized areas of Cumberland and Frostburg, as shown in Map 3, but this is also a function of the population density in these areas.




Map 2 Minority Population Distribution (Source: American Community Survey (5-year) Estimates

Map 3 depicts the high concentration of the population below poverty level in Cumberland, Frostburg, Luke, and Westernport.

INCOME

Table 6 includes estimates of the average annual income for Allegany County in 2020 by source of income as well as family income by numbers of workers within the family. Of the total households, the average income was estimated to be \$59,245. The second half of the table estimates average annual income by the number of workers in a family. It is not surprising that families with 3 or more workers had the highest average income (\$113,955), and families with no workers had the lowest average income (\$41,396).



OVER VIEW OF PRESERVED LANDS AND RECREATIONAL PARK LANDS

Map 4 Recreational & Park Lands & Appendix A – Overview Map show the large parcels of state park and recreational lands in the eastern and western portions of Allegany County. This area also contains steep slopes which also warrant preservation. This map also depicts the cross-county trail system; which is comprised of the Great Allegany Passage (22 miles) and the C&O Canal Towpath (54 miles.) These nonmotorized trails continue beyond the County boundaries and span a traffic free greenway, totaling 330 miles of trail, between Washington, DC and Pittsburgh, PA.

OVERVIEW OF PARKS AND RECREATION SYSTEM

Allegany County does not have a Department of Parks and Recreation, but the County is blessed with several State-owned parks, including Rocky Gap and Dan's Mountain State Park, and also seven municipalities that manage recreation within their jurisdictions along with a number of Community based Civic Improvement and Athletic Associations.

Open Space funding has been the main funding source to improve recreational facilities within the County.

Every March, the County Public Works-Engineering Division solicits requests from jurisdictions for projects to upgrade or expand recreational facilities. A committee of County employees review the requests and discuss each project with the jurisdictions. In 2021, many jurisdictions needed new bleachers and the County grouped a large project together to obtain a better price for the bleachers. The Committee prioritizes the request, and recommends the list to the Board of County Commissioners for adoption.

Noteworthy recreational projects for the period 2018 to 2022:

- Willowbrook Outdoor Wellness Center (WOW) Project. Allegany College of Maryland is planning
 to donate 26 acres to Allegany County to develop two football/soccer fields, fitness area, trail
 network and a fishing pier. This project is currently in the planning phase. Estimated project cost is
 estimated to be \$3 million dollars and proposed funding will come from the National Parks Land &
 Conservation Fund, Project Open Space and Local Parks and Playground Infrastructure Fund
- The County, with funding from the Maryland Department of Natural Resources, constructed a new boat ramp on the Potomac River, at the Upper Potomac Industrial Park
- The County installed 25 water and sewer camping hookups, a new bathroom, and installed new fencing at the Allegany County Fairgrounds
- The Piney Plains Civic Association made plans to improve and utilize a field that had been left unattended for years.
- The City of Frostburg added a trail, playground and made numerous improvements to the Hoffman Community Park, a destination for a number of community events.

FINANCIAL SUPPORT

The County continues to utilize the state sponsored Program Open Space to purchase and develop parks in communities within the County. Program Open Space will continue to be the primary source of non-local funds for recreational projects in Allegany County. A few community parks, notably in LaVale and Cresaptown, are privately owned and funded. See Appendix B- Program Open Space Projects 2018- 2022.

Municipalities and school related groups have also received grants from the State of Maryland's Community Parks and Playgrounds program. That program deals directly with the DNR Land Acquisition and Planning's Western Maryland Regional Office.

COUNTY GOALS

Successful communities recognize that access to public recreation promotes the importance of physical and mental health. Recreation also provides positive social interaction, which is one of the major avenues by which residents can begin to establish ties to the community. In this regard, the provision of adequate recreational space and facilities is not simply a matter of providing leisure time activities but is an essential part of maintaining public health, safety and welfare and promoting social and community cohesion. The County goals are as follows:

- Establish a County Committee that will visit and prepare a report on the conditions of recreational facilities within the County.
- Make a variety of quality recreational environments and opportunities readily accessible to all of its citizens and thereby contribute to their physical and mental wellbeing
- Continue to develop the Fairgrounds to its fullest potential. The County looks to maximize the Fairgrounds to host large scale recreation events such as the County Fair, Delfest, the Tri-state Wing Off, and meetings for community groups.
- Utilize the current trail network to promote physical activity and healthy lifestyles. Support community partnerships that seek to increase tail network connectivity, and access to recreational opportunities without reliance on the automobile.
- Update or replace amenities at existing facilities and provide for additional amenities as the needs of the population of Allegany County change in order to make the County a desirable place to live, work, play, and grow. The County will continue to address underserved areas, when feasible.

- Make a variety of quality recreational environments and opportunities readily accessible to all its citizens and thereby contribute to their physical and mental well-being.
- Recognize and strategically use parks and recreation facilities as amenities to make communities, counties and the State more desirable places to live, work, play and visit.
- Use state investment in parks, recreation and open space to complement and mutually support the broader goals and objectives of local comprehensive/master plans.
- To the greatest degree feasible, ensure that recreational land and facilities for local populations are

conveniently located relative to population centers, are accessible without reliance on the automobile and help to protect natural open spaces and resources.

- Complement infrastructure and other public investments and priorities in existing communities and areas planned for growth through investment in neighborhood and community parks and facilities.
- Continue to protect recreational open space and resource lands at a rate that equals or exceeds the rate that land is developed at a statewide level.

COMPARISION OF COUNTY AND STATE GOALS FOR PARKS AND RECREATION

Generally, the County's and State's goals are aligned in addressing both specific and general aspects of recreation planning, such as preserving open space, natural resources, and meeting the needs of the community to make Allegany County and Maryland a place that is desirable to live, work and play. The County goals for parks and recreation mirror or slightly differ from the state's goals to promote access to recreation and encourage redeveloping facilities. A goal more specific to Allegany County is to address the changing needs of the aging population.

Both sets of goals address access to recreational opportunities without reliance on the automobile and to promote physical activity.

The goal about improvements to the Allegany County Fairgrounds are specific to the County but relates to the State's goal to developing conveniently located facilities and infrastructure near population centers. The Fairgrounds is in a designated growth area.

PROGRESS FROM 2017

The following goals are from the Allegany County Land Preservation, Parks and Recreation Plan 2017, along with a description of the progress of how those goals have been carried out

GOAL I: Make a variety of quality recreational environments and opportunities readily accessible to all its citizens and thereby contribute to their physical and mental well-being.

2022 PROGRESS

County continues to upgrade and expand recreation facilities. A new boat ramp was installed at the Upper Potomac Industrial Park and new one is planned for Westernport. Pickleball courts were constructed at Bel Air Community Park and are planned for the Cresaptown Park. Cumberland skate park is in the planning stages, and Tracks and Yaks (the only Rail Biking excursion on the East Coast) began operation in Frostburg. The Canal Place River Walk is in the planning stage.

GOAL 2: Continue to develop the Fairgrounds to its fullest potential. The County looks to maximize the Fairgrounds ability to host large scale recreation events such as the County Fair, Delfest, Tri-state Wing Off, and meetings for community groups.

2022 PROGRESS

Improvements included constructing a new bathroom (with County forces), adding twenty-five (25) new water/sewer camping hookups, and fencing improvements.

GOAL 3: Utilize the current trail network to promote physical activity and healthy lifestyles. Support community partnerships that seek to increase trail network connectivity, and access to recreational opportunities without reliance on the automobile.

2022 PROGRESS

New trail added to the Hoffman Community Park. Sheriff's Department Alternative Sentencing group took over maintenance of the Great Allegheny Passage, New trails planned for Ellerslie Community Park and Constitution Park in Cumberland

GOAL 4: Update or replace amenities at existing facilities and provide for additional amenities as the needs of the population of Allegany County change in order to make the County a desirable place to live, work, play, and grow.

GOAL 5: Continue to address underserved areas when feasible.

COMBINED GOAL 4 & 5 2022 PROGRESS

County continues to upgrade facilities with Open Space funding. A new recreational complex, the Willowbrook Outdoor Wellness Center, is planned near the Allegany College of Maryland.

COMMUNITY BENEFIT

Results from the Survey Monkey data show that residents would like to see the upkeep and maintenance on existing parks become more prioritized. Many residents utilize the rural landscape of Allegany County for outdoor recreation such as hiking, picnicking, boating and kayaking. Allegany County's rural nature encourages residents to utilize outdoor recreation sites, but funding for facility updates is a routine challenge the County encounters. Funding from these programs would be used to increase the safety and accessibility to these parks. By ensuring recreation sites are well maintained and safe to visit, residents will be encouraged to capitalize on the physical and mental wellness benefits that outdoor recreation is able to offer.

Outdoor recreation has been shown to improve mental and physical well-being in a multitude of ways. For example, outdoor recreation is able to reduce stress, improve sleeping habits, and increase lifespan.

MENTAL AND PHYSICAL WELLNESS BENEFITS

Being outdoors and enjoying both field/court-based recreation and natural recreation has many mental and physical wellness benefits. For example, outdoor recreation has been associated with a lower risk of depression, faster psychological stress recovery, and strengthening of certain mental capacities such as increasing focus and attention. In addition to the various mental wellness benefits that are associated with outdoor recreation, there are many physical benefits that are linked to enjoying the outdoors.

Enjoying outdoor recreation is also able to promote healthier lifestyles through the variety of active opportunities that can be enjoyed. There is evidence to suggest that natural outdoor activities can increase a person's motivation to exercise and develop a healthier lifestyle, which in turn is able to increase life expectancy, improve sleep quality, and reduce cardiovascular disease and cancer risk.

Allegany County has been blessed with beautiful outdoor scenery and available recreation activities. Adequate funding will ensure that the existing outdoor parks and recreation sites are easily accessible, well maintained, and safe to visit for residents.

ALLEGANY COUNTY PUBLIC SCHOOLS ENVIRONMENTAL LITERACY PROGRAM

The Allegany County Board of Education offers Outdoor School, and After School Program to students in

Allegany County's public-school system. Every student has a meaningful outdoor education experience from kindergarten to grade 12. For example, seventh graders, spend two-and-a-half days at Rocky Gap and Canal Place and fifth graders have outdoor school at the Evergreen Heritage Center. Due to the current coronavirus situation, several events have been cancelled. The Evergreen Heritage Center is currently coming to the schools to teach their programs.

IMPLEMENTING PROGRAMS

OPEN SPACE, GREENWAYS, AND PARKS

Program open space continues to be the main funding program for Allegany County to upgrade the recreational facilities within the County. Appendix B provides a list of projects completed with Open Space funding from 2018-2022.

COMMUNITY PARKS AND PLAYGOUNDS

The Community Parks and Playgrounds Program provides funding to focus on restoring existing and creating new parks and green space systems in Maryland's cities and towns. Awards are competitive in nature and applications are accepted every year.

LAND AND WATER CONSERVATION FUND

The State Side of the Land and Water Conservation Fund provides matching grants to States and local governments for the acquisition and development of public outdoor recreation areas and facilities. Funding from this program will be included to develop 26 acres of property that Allegany County is acquiring from the Allegany College of Maryland for the Willowbrook Outdoor Wellness Center.

STATE WATERWAY IMPROVEMENT FUND


This program provides financial support to local governments for a wide variety of capital projects and services for the boating public. Allegany County has constructed two boat ramps for access to the Potomac River with this program, the most recent being constructed at the Upper Potomac Industrial Park in 2018.

PARKS AND RECREATION FACILITIES INVENTORY

Parks and open space include a variety of recreation areas and facilities to meet the needs of Allegany County's residents and visitors. Park and recreation facilities can also be established to preserve, conserve and manage natural resources and habitats. The following are some classifications and examples of land in Allegany County. Map 5 Recreation Site Points





Figure 12 DNR Maintained Land

State Owned Public Lands

The Maryland Department of Natural Resources manages 68,306 acres of land in Allegany County. Allegany County is home to the second largest state-owned forests in the State. The thousands acres shown in Figure 12-DNR Maintained Land in the County represents significant ecological and cultural landscapes that provide residents with the outdoor recreation opportunities such as wildlife observation, photography, boating, fishing, hiking, hunting, mountain biking, and camping. In addition to more than 65,000 acres of preserved lands, residents have access to 155 public parks. Please reference Appendix C- Allegany County Inventory of Parks and Recreation Facilities to see additional parks and recreation sites available within the County.

Public Water Access Sites

County residents are able to enjoy the public water trail that includes eleven public water access sites. Residents are able to access these sites through both boat ramps and soft launches. Residents are able to enjoy a multitude of recreational activities throughout the County such as boating, swimming, canoeing, kayaking, camping, and picnicking. These are significant recreational features within the County that include the State-Designated Potomac River Water Trail section as well as the Federally owned and managed C&O Canal NHP. Map 6 depicts the general locations of the available public access sites throughout the area.

NEIGHBORHOOD PARK S

The 22, small-scale neighborhood parks provide outdoor recreation opportunities for families that are conveniently located in more densely populated urban settings. The parks give residents of these neighborhoods some outdoor space beyond the home that is conveniently located, where they casually meet and/or engage in unorganized play and enjoy open space. Due to the distribution of population in Allegany County neighborhood parks and playgrounds occur in municipalities.

COMMUNITY PARKS

The 61 Community Parks that have been developed within the County larger populations than serve neighborhood parks. Allegany County developed parks in municipalities, unincorporated suburbs, and smaller rural communities. Residents former mining or company towns of the George's Creek region of the County tend to gravitate towards Community parks in municipalities of the region. Community Parks also provide amenities such as playground equipment. The County relies on community groups or public service organizations to operate, maintain, and provide programming of

recreational activities. While the properties are owned by the County, they are largely supported and maintained by residents. Residents are able to see their community's social wellbeing benefit from actively and collectively maintaining their local parks.

SCHOOL RECREATION FACILITIES

School recreation facilities are located at school properties in urban, suburban and rural community settings. There are 23 school recreation facilities. The County's elementary schools have almost all been provided play equipment funded through POS. The County's middle and high school playing fields are open to the public when not in use by school teams.

REGIONAL PARKS, WILDLIFE MANAGEMENT AREAS, AND STATE FORESTS

54 Regional Parks in Allegany County include recreational facilities of Allegany College of Maryland and Frostburg State University. Other parks of regional significance include Cumberland's Constitution Park, Canal Place, the Allegany County Fairgrounds, and the Maryland portion of the Great Allegheny Passage (GAP.) These facilities contribute to the County's economic health as components of its eco-tourism infrastructure.

TR ALLS

Many residents and visitors have embraced the recreational aspect of biking, walking, and using the C&O Canal, Great Allegheny Passage, and other existing local hiking and biking trails. The County's roadways, on

the other hand, are primarily used for automobiles, but there is opportunity to improve their capacity for non-motorized transportation.

Allegany County's existing trail systems are used by residents and visitors of Allegany County. The main systems spanning east to west in the County are the Great Allegheny Passage and the Chesapeake and Ohio Canal National Historical Park Towpath. These trails meet in Cumberland and provide a non-motorized connection from Georgetown (near Washington, DC) to downtown Pittsburgh, Pennsylvania.

The other existing system of trails can be found in Rocky Gap State Park. That system consists of four trails, three of which are spurs to the main Lake Loop Trail that follows Lake Habeeb's shore. Green Ridge State Forest also provides I I trails for recreation. Most trails in Green Ridge State Forest are moderately challenging hiking trails due to the steep terrain. See Appendix G -Trail Inventory Map

PRIVATELY OWNED RECREATION FACILITIES

The inventory identifies 50 properties for recreational use but are owned by a private or nonprofit entity. Some of these sites are open to the public, but others require a membership, or rental fee. An example of a privately-owned facility is the Ali Ghan Shrine Club's Picnic Grounds. It is a gated area that can be rented for events; the area has playground equipment, pavilions and other amenities.

MEASURING USER DEMAND

PUBLIC OUTREACH

- A project request for Open Space Funding is sent out to all seven municipalities every March.
 Once the list is compiled, a County review committee reaches out to requestor with any questions.
- In October 2018, The Nature Conservancy completed the Western Maryland Woodland and Wildlife Management Survey. See Appendix H.
- Meetings were held in November and December of 2020 with local sports organizations to determine the project scope for development of 26 acres, that Allegany College of Maryland is donating to Allegany County for the Willowbrook Outdoor Wellness Center project.

To assist with the project development, the Allegany County Outdoor Recreation Survey was completed. See Appendix I.

A \$2 million dollar development project consisting of two football/soccer fields, fitness area, trail network and a fishing pier is planned for this site. Funding will come from the National Parks Land and Conservation Fund, Program Open Space and Local Parks and Playgrounds Infrastructure Fund.

SURVEY MONKEY

Allegany County conducted an online survey in January 2022 for public input on park and recreation sites within the County. The survey contained questions that will help Allegany County improve some of our greatest recreational assets. The survey was made through www.surveymonkey.com. The survey was posted on the County's website as well as social media sites. 299 people, in total, were surveyed. Full results from the survey can be found in Appendix K – LPPRP Survey Monkey Survey Results

According to the survey, the following are the top ten most visited sites in Allegany County

- I. Rocky Gap State Park
- 2. Allegany County Fairgrounds
- 3. C&O Canal
- 4. Great Allegheny Passage
- 5. Constitution Park
- 6. Dan's Mountain State Park
- 7. Allegany College of Maryland
- 8. Dan's Rock Overlook Park
- 9. Green Ridge State Forest
- 10. Frostburg State University

Outreach

Items to consider after reviewing the survey include:

- I. Maintenance and upkeep of recreational facilities needs improved. This has been the focus when utilizing Open Space Funding.
- 2. Hiking, biking, and outdoor activities are very important to County residents.
- 3. Skateboard Park and disc golf are new ideas many residents would like to see added. The City of Cumberland is currently working on the planning of a new skateboard park.
- 4. The County needs to advertise and market the abundant number of recreational facilities within the County.

Maintenance and upkeep of existing recreational facilities was the most received comment according to the Survey Monkey data. This shows that while residents are utilizing available recreation sites, sites need to be updated. As stated above, this is the focus of most of the funding provided through Program Open Space. Proper upkeep of sites will encourage residents to use and enjoy the available outdoor recreation sites to their full potential.

Due to the ease of completing the survey with the Survey Monkey application, the County will revise the current survey and complete the survey on an annual basis, in order to keep current with the needs of County residents.

DATA ON USAGE, DEMAND AND PARTICIPATION RATES

Since Allegany County does not have a parks and recreation department, data on participation at some of the recreation sites have been gathered from the City of Cumberland, City of Frostburg, Allegany County Fairgrounds, Athletic Associations and State Parks. Table 5 contains participation data for the Fairgrounds, Great Allegany Passage, and other recreation facilities.

According to the usage data, Rocky Gap State Park is highly used. This information correlates to the County's online recreation survey. According to the survey, the most important assets were hiking and biking trails, both the Great Allegany Passage and Rocky Gap show a high participation rate.

The Frostburg Dog Park is reported to have over 14,000 visitors to the site in a year. Based on the survey, there is demand for more of these types of facilities. In Allegany County, there is only one other dog park at Constitution Park. Improvements to the Dog Park in Constitution Park are warranted for the site to meet modern dog park design criteria.

This enumeration of participation is not complete, there are many more active leagues and athletic clubs, this demand can be seen in the POS funding over the last six years. Many of the projects improved sports fields and courts.

ANALYZING USER DEMAND

PUBLIC RECREATION PROXIMITY ANALYSIS

Unstructured outdoor time is important for the well-being of everyone. Evidence suggests that exposure to nature can improve attention and promote self-confidence, calmness, and other psychological aspects of health. Unstructured outdoor play produces positive developmental and health benefits for all residents, including those from rural communities to those in urban and suburban neighborhoods.

GIS-based proximity analysis was done to model the accessibility of public recreation sites throughout Allegany County, based on driving distance.

Driving is the most common mode of transportation in Allegany County. Over 88% of households in Allegany County own at least one vehicle, based on the 2016 American Community Survey data. Of the 3,126 estimated households without access to a vehicle, 87% or 2,723 estimated households without access to a vehicle are in the urbanized and walkable Cities of Cumberland and Frostburg. Furthermore, these cities have higher accessibility to public transit options.

Given the County's rural nature, the average commute time is 20.2 minutes. Recreation is often seen as something to do in one's spare time, and therefore convenience to access public recreation spaces is a priority. This Proximity Analysis will model travel time convenience, using 15, 10, and five-minute drive times to public recreation points.

METHOD

A GIS-Based Proximity Analysis was done to evaluate accessibility to public recreation lands in Allegany County, based on driving distance from residences.

This analysis began by selecting only the publicly accessible recreation points from the recreation inventory. In addition, points of interest for Green Ridge State Forest and access points for the C&O Canal were added since these parks are vast and have multiple points of entry.

Inputting public recreation points and a road network that considered speed limit, traffic signals, and traffic volume, the following drive time polygons were generated, 15-minute, 10-minute, and 5-minute. These distance polygons were overlaid with the County's address point file, to provide a general sense of development clusters in the County. Please note that these address points represent occupied housing units and commercial, institutional, and other E-911 address points.

RESULTS






Figure 18 Town Creek

In addition to the Park Equity analysis conducted, as seen in Figure 18, several proximity analyses were also completed. These include proximity analyses for water access, natural resources, picnic facilities, and trails. These analyses can be found in Appendix L- Park Proximity Analysis Maps, and results conclude that despite its ruralness, Allegany County is able to provide residents with sufficient access to public recreation, and Allegany County has met its land acquisition goals. There are gaps in access in the eastern part of the County due to the amount of federally owned and protected land in the Green Ridge State Forest. Results from the proximity maps are highlighted in the Park Equity Analysis Map. Most of the County scored very high or high with regard to park equity.

Addressing areas where the community is underserved is greatly influential in where the County chooses to allocate time and resources for outdoor recreation advancement. Results from the analyses conducted are incorporated into planning and can be witnessed in the County's goals and planned projects that are discussed in this plan.


PARK EQUITY ANALYSIS

Map 7, Park Equity, found below, displays the Total Park Equity Score of each of the census tracts within the County. Many of the census tracts within the County scored with Very High Equity, or High Equity, ranging in score from .05 to .25. However, census tracts surrounding the Green Ridge State Forest are among the lowest-scoring tracts within the County. The population density in this area is lower in comparison to the larger towns and cities such as Cumberland, Frostburg, and LaVale. Among low population density, the distance to public transportation, walkability, and the concentration of low-income households are contributing factors as to why these tracts scored low. This is extremely helpful in identifying parts of the County that are underserved. Funding from available programs and grants would aim to combat this discrepancy found in the eastern part of the County, while also working to preserve the steep slopes and high-value forestry lands. These components are key in addressing many of the County's goals that are outlined in this plan.

Map 7- Park Equity Analysis




Below is the 15-minute interval map that shows that 99.58% of the land is within driving distance to a parks or recreation facility. The areas not covered by the 15-minute distance polygon are areas with limited road access, areas of steep slopes, or public lands owned by the State.

In addition to the 15-minute driving interval, a 10-minute and 5-minute driving interval map was generated. The results of this analysis yielded over 96% of the address points being within ten minutes driving time and 86% being within five-minute driving time to an existing public recreation site. The large tracts of State-owned public lands depicted above lie outside of the 10-minute driving distance from existing public recreation sites, but are able to provide rural recreation opportunities. Given the County's rural nature, Allegany County residents drive a considerable distance to amenities such as grocery stores and for employment. Having recreation opportunities within a 10-minute drive demonstrates that Allegany County is well served by its existing parks, trails, open spaces, forests, and other public recreation lands.

On May 1, 2022, Allegany County received a letter from the Maryland Department of the Natural Resources. The letter outlines available funding that is available through Program Open Space, and states "Since Allegany County has met its local land acquisition goal in the current, approved, Land Preservation Parks and Recreation Plan, and the Maryland Department of Natural Resources owns more than 65,000 acres of land..." Allegany County does not plan to acquire any more federally protected land at this time.



Based on the community survey results in the plan, the greatest public recreation needs in Allegany County are improvements to a user's experience. When asked, "Do you feel enough attention is given to the

recreation facilities you frequent?" Many respondents felt that not enough attention is given the current recreation facilities. This is also demonstrated by a review of the POS applications over the last decade, which consistently request funding for upgrades to existing facilities.

As for addressing the desires expressed in the public outreach, the City of Cumberland is hoping to complete the Constitution Park Trail Plan. The projects in the recommendation of the plan may lead to more paved trails in the park and perhaps other parks in Cumberland, including an improvement to dog park amenities, and diversity in future programs and events.

CAPITAL IMPROVEMENT PLAN

The Parks and Recreation CIP contains only the current recreational proposals submitted by the County's Municipalities. Many Capital Improvement Plan entries for FY 2022 include projects from the 2022 Annual Plan for Program Open Space.

As illustrated in the Parks and Recreation Survey, many parks need new equipment and amenities, known as Capital Redevelopment. The County's long-standing goal of improving existing parks accounts for much of the Program Open Space funding.

Trails and paths were requested from the public outreach, these community playground projects will try to incorporate walking paths and trails that communities can access without the reliance on automobiles.

Enacted by the General Assembly in 1997, Maryland's Rural Legacy Program dedicates funds to preserve valuable farmland, forest, and natural areas. In 2010, the County's Mountain Ridge Rural Legacy Area was approved by the State of Maryland. Today the County has more than 1,300 acres preserved through the Rural Legacy Program. See Appendix L – Rural Legacy Map and Appendix - Federally Protected Lands.

The State of Maryland has preserved 67,184 acres, or 24.6% of Allegany County's land area, in Wildlife Management Areas, State Forests and State Parks. The Chesapeake and Ohio National Historical Park consists of 3,205 acres of protected land as well. Adding the locally preserved land to State and Federal lands preserves approximately one acre of land per County resident.

Since 2017, approximately 113 acres of forested stream buffers have been implemented as part of the County's Phase II Watershed Implementation Plan (WIP) for the Chesapeake Bay TMDL. This reforestation was completed in large part via partnership with DNR Forest Service. Also, since 2017 approximately 68 acres of urban tree canopy, 202 acres of reforestation on mine lands, 27 acres of bioretention, 13 acres of filtering practices, and 1,230 linear feet of stream restoration have been implemented throughout the County.

COUNTY GOALS

Natural resource conservation lands prove many environmental and social benefits including filtration of air, water, outdoor recreational opportunities, economic and public health benefits, and wildlife habitat, and biodiversity. Preserving natural resources sustain a functional ecosystem which in turn provides benefits to inhabitants of Allegany County.

The following goals are reiterated from the 2017 LPPRP and complement objectives and recommendations the from the 2014 Comprehensive Plan's Sensitive Area Element and Agricultural, Forestry and Non-Mineral Resources Element.

Continue to protect steep slopes, floodplains, and sensitive areas. Steep slopes are defined in County Code as any slope greater than 25%.

- Maximize conservation of areas that have high forestry value as well as areas that have a high natural resource value. If these properties are within the Mountain Ridge RLA, encourage participation within that program.
- Continue to encourage citizens to participate in the Rural Legacy program, the Maryland Environmental Trust program, as well as the Conservation Reserve Enhancement Program.
- Increase the connectivity and use of Allegany County's greenways in order to preserve habitat corridors and boost economic development through the appreciation of natural resources.
- Facilitate additional wetland and buffer protection from development impacts and promote interagency coordination regarding wetland permits and mapping applications.
- Implement a View-shed Protection Overlay Zone. This would protect mountain tops from development that would impact the view of the mountains and may disrupt the eco-tourism that is being established in the County.
- Create, maintain, improve, and increase the quantity and quality of open space and greenways within Allegany County to facilitate and preserve wildlife habitat corridors and preserve the scenic aesthetics of Allegany County.
- Continue to discourage development within the 100-year floodplain. Identify properties that are within the revised floodplain maps from USGS and target potential sites for flood buyouts through grant funding and other Federal Emergency Management Agency programs.

STATE GOALS

- Identify, protect and restore lands and waterways in Maryland that support important aquatic and terrestrial natural resources and ecological functions, through the combined use of the following techniques
 - o Public land acquisition and stewardship,
 - Private conservation easements and stewardship practices through purchased or donated easement programs,
 - Local land use management plans and procedures that conserve natural resources and environmentally sensitive areas and minimize impacts to resource land when development occurs,
 - Support incentives for resource-based economies that increase the retention of forests, wetlands, or agricultural lands,
 - Avoidance of impacts on natural resources by publicly funded infrastructure development projects,
 - o Appropriate mitigation response, commensurate with the value of the affected resource.
- Focus conservation and restoration activities on priority areas, according to a strategic framework such as the Targeted Ecological Areas (TEAs) in GreenPrint (which is not to be confused with the former easement program also called GreenPrint).
- Conserve and restore species of concern and important habitat types that may fall outside of designated green infrastructure (examples include rock outcrops, karst systems, caves, shale barren communities, grasslands, shoreline beach and dune systems, mud flats, non-forested islands, etc.).

Develop a more comprehensive inventory of natural resources lands and environmentally

sensitive areas to assist state and local implementation programs.

Established measurable objective for natural resource conservation and an integrated state/local strategy to achieve them through state and local implementation programs.



Asses the combined ability of state and local program to achieve the following

- Expand and connect forests, farmland and other natural lands as a network of contiguous green infrastructure;
- o Protect critical terrestrial and aquatic habitats, biological communities and populations;
- Manage watersheds in ways that protect, conserve and restore stream corridors, riparian forest buffers, wetlands, floodplains and aquifer recharge areas and their associated hydrologic and water quality functions;
- Adopt coordinated land and watershed management strategies that recognize the critical links between growth management and aquatic biodiversity and fishery production; and
- O Support a productive forestland base and forest resource industry, emphasizing the economic viability of privately owned forestland.

COMPARISON

The County goals mainly complement the State Goals. For example, both sets of goals state to conserve natural resources by acquiring public land and stewardship, not developing in floodplains, on steep slopes and sensitive areas. Both sets of goals address preserving wildlife habitat and connectivity of greenways and forests. One of Allegany County's goals also mentions eco-tourism, preserving the natural resources can be an economic benefit to this area, drawing visitors and providing recreational sites for residents.

There is no mention of the Targeted Ecological Areas (TEAs) in GreenPrint in the County Goals, this will be something the County will look to the State for resources to better highlight areas to be preserved, in future LPPRP. This goal goes hand in hand with a comprehensive inventory as mentioned in the state goals. Since Allegany County does not have a parks and recreation department, the people power is lacking for a comprehensive inventory for natural resources and environmentally sensitive areas. Perhaps state resources can be shared with the County to better achieve their goal.

PROGRESS SINCE 2017

Even though the County maintains the 2017 goals in the 2022 plan and continues to work toward them in their policies and administrative procedures, the following provides a summary on the progress that has been made on each of the goals.

GOAL I Continue to protect steep slopes, floodplains and sensitive areas. Steep slopes are defined in County Code as any slope greater than 25%.

2022 PROGRESS

Protection of these sensitive areas continues to be implemented through enforcement of zoning, subdivision and development regulations.

GOAL 2 Maximize [conservation of] areas that have high forestry value as well as areas that have a high natural resource value. If these properties are within the Mountain Ridge RLA, encourage participation within that program.

2022 PROGRESS

Five Rural Legacy easements have been purchased on more than 1,300 acres of mostly forested land since 2017.

GOAL 3 Continue to discourage development within the 100-year floodplain. Identify properties that are within the revised floodplain maps from USGS and target potential sites for flood buyouts through grant funding and other Federal Emergency Management Agency programs.

2022 PROGRESS

The County continues to enforce its Floodplain Management code through site plan review and subdivision review.

GOAL 4 Continue to identify areas where Greenways could be used to link urban areas and parks within the County.

2022 PROGRESS

The County has implemented a riverine greenway system through the Waterway Improvement Program on the North Branch of the Potomac River and through repetitive loss programs mentioned above.

GOAL 5 Implement a View-shed Protection Overlay Zone. This would protect mountain tops from development that would impact the view of the mountains and may disrupt the eco-tourism that is being established in the County.

2022 PROGRESS

Rural Legacy easement acquisitions partially accomplished this goal in preserving views of the mountains from the National Road Scenic Byway. Additional easement purchases are under review.

GOAL 6 Continue to encourage citizens to participate in the Rural Legacy program, the Maryland Environmental Trust program, as well as the Conservation Reserve Enhancement Program.

2022 PROGRESS

The County submits an annual list of candidate properties for the Rural Legacy program.

CHAPTER 4 AGRICUTURAL LAND PRESERVATION

The Maryland Agricultural Land Preservation Foundation (MALPF) has a primary purpose of preserving sufficient agricultural land to maintain a viable local base of food and fiber production for the present and future citizens of Maryland. The program purchases perpetual agricultural conservation easements on eligible farmland throughout the state.

The first land preservation easement sponsored by Allegany County occurred in 1990 with the purchase of the development rights of the Leaning Tree Farm located near Mount Savage. Fifteen Maryland Agricultural Land Preservation Foundation (MALPF) easements have been purchased, preserving 1,868 acres of productive farmland supplying residents of Allegany County the food and fiber necessary for their wellbeing. The "farm to table" movement has prospered in Allegany with several farmers' markets in year-round operation and restaurants emphasizing their serving of locally produced foods. Please see Appendix O- Inventory of MALPF Easements.

The vast majority of agricultural land in the County corresponds directly with the States goals of preservation. Allegany County continues to develop its land preservation alongside the goals of the State and is a large contributor to the thousands of acres already preserved. Since 2017, there have been almost 450 acres of land preserved in Allegany County under the direction of the Maryland Agricultural Land Preservation Foundation.

COUNTY GOALS

- Establish a Priority Preservation Area.
- Continue to utilize both Maryland Agricultural Land Preservation Foundation (MALPF) and Rural Legacy on an annual basis.
- Work to become a "Certified" County. Certification allows the County to keep more of the Agricultural Transfer taxes generated within the County,
- Continue to encourage property owners to voluntarily participate in Land Preservation Programs through MALPF and Rural Legacy. This is the top long-term protection of Allegany County's agricultural and forested land resources,
- Maximize areas with increased agricultural value,
- Minimize the amount of prime agricultural land converted from agricultural use to accommodate permitted non-farm development,

STATE GOALS

- Permanently preserve agriculture capable of supporting a reasonable diversity of agricultural production;
- Protect natural, forestry, and historic resources and the rural character of the landscape associated with Maryland's farmland;
- To the greatest degree possible, concentrate preserved land in large, relatively contiguous blocks to effectively support long-term protection of resources and resource-based industries.
- Limit the intrusion of development and its impacts on rural resources and resource-based industries,
- Ensure good return on public investment by concentrating state agricultural land preservation funds in areas where investment is reasonably well supported by both local investment and land use management programs,
- Work with local governments to achieve the following:
 - Establish preservation areas, goals and strategies through local comprehensive planning processes that address and complement state goals,
 - In each area designated for preservation, develop a shared understanding of goals and the strategy to achieve them among rural landowners, the public-at-large and state and local government officials.
 - Protect the equity interests of rural landowners in preservation areas by ensuring sufficient public commitment and investment in preservation through easement acquisition and incentive programs;
 - Use local land use management authority effectively to protect public investment in

- preservation by managing development in rural preservation areas.
- Establish effective measures to support profitable agriculture, including assistance in production, marketing and the practice of stewardship, so that farming remains a desirable way of life for both the farmer and the public-at-large.

COMPARISON OF COUNTY AND STATE GOALS

Generally, and in many ways, specifically, Allegany County's goals for Agricultural Land Preservation are compatible with the State Goals shown above. Establishing a Priority Preservation Area (PPA) and achieving certification of the County's program would enable the County to accomplish the State goals regarding public commitment to preservation. The County has effectively protected contiguous blocks of farmland with MALPF easements in the Mount Savage.

PROGRESS SINCE 2017

The Following County goals were stated in the 2017 LPPRP.

GOAL I Establish a PPA

2022 PROGRESS

The County has not established a PPA.

GOAL 2 Continue to submit to both Maryland Agricultural Land Preservation Foundation (MALPF) and Rural Legacy on an annual basis.

2022 PROGRESS

MALPF applications are submitted every other year per MALPF's direction.

GOAL 3 Work to become a "Certified" County. Certification allows the County to keep more of the Agricultural Transfer taxes generated within the County.

2022 PROGRESS

The County has not yet applied for certification.

GOAL 4 Continue to encourage property owners to voluntarily participate in Land Preservation Programs through MALPF and Rural Legacy.

2022 Progress


The County's Division of Land Development Services staff consults with landowners and where applicable, the County's Land Preservation programs. The County Planning Coordinator is the County "point person" for land subdivision activities which provides additional opportunities to discuss Land Preservation programs. The County Soil Conservation District staff also performs valuable outreach, informing landowners of the possibility of placing their property under preservation easement.

GOAL 5 Maximize areas with increased agricultural value (as depicted in Chapter 9 Agriculture, Forestry and Non-Mineral Resources of the 2014 Allegany County Comprehensive Plan).

2022 PROGRESS

MALPF's priority is to preserve the most productive soils. Staff work cooperatively with Allegany Soil Conservation District to ensure that the most productive farmland is proposed for preservation.





OVERVIEW OF RESPONDERS

The survey was mailed in September 2018 to a random sample of 2,000 western Maryland landowners from a pool of 4,083 private individuals with ten acres or more. We then mailed a reminder postcard approximately 2 weeks after the initial survey was sent.

We received 344 responses by October 8th 2018, or a 17.2% response rate. Of these, 68% (234 landowners) indicated that they would like to learn more about habitat management for wildlife on their land. The average acres (as indicated by tax data) of the total population of private landowners in western Maryland is 72.63 acres, with a median of 35.90 and standard deviation of 134.61. The average acres of survey responders (as indicated by tax data) is 71.16, with a median of 41.27 acres and a standard deviation of 82.83 acres. This suggests that our survey data is likely representative of the population of western Maryland landowners when considering tax-reported total acres, but that fewer very large landowners answered our survey than are in the population. However, our sample *may not* be representative of the whole when considering type of landowner; for example, unengaged landowners may be less likely to respond and landowners who care about their land or are active on their land may be more likely to respond because this sort of survey would interest them. In addition, landowners that trust MD DNR and/or TNC may be more likely to respond due to branding. We did attempt to minimize response bias by offering an incentive of three randomly selected gift card winners.

DEMOGRAPHICS

GENDER (Q13)

Eight out of ten respondents (80%) were male and two out of ten (20%) were female.

AGE (Q12)

The plurality of respondents (48%) were between ages 40-65, 48% were over age 65, and 4% were under age 40.

RETIREMENT STATUS (Q14)

Just over half of respondents (53%) were retired and 47% were not retired.

OWNERSHIP (QI)

All respondents confirmed that they are landowners in either Garrett or Allegany. Most respondents (57%) own land in Garrett County only, 41% own land in Allegany County only, and 2% of respondents own land in both counties.

NUMBER OF PARCELS

The mean number of parcels is 2.1 and the median is 1. The majority (53%) of respondents have one parcel. About one quarter (26%) have two parcels, 12% have three parcels, 4% have four parcels, 2% have five parcels, 1% have six parcels, 1% have seven parcels, and one landowner (.32%) has eight, nine, seventeen, 33 and 34 parcels.

NUMBER OF ACRES

The mean number of total acres is 89.4 and the median is 48, with a range of 2.5-1325 acres. The middle fifty percent of respondents owns between 22 and 100 acres.

NUMBER OF FORESTED ACRES

The man number of forested acres is 62.37 and the median is 30 acres, with a range of 0-900 forested acres. The middle fifty percent of respondents own between 15 and 69.5 forested acres. On average, 72.7% of landowners' total acres are forested.

LENGTH OF OWNERSHIP (Q3)

The mean length of ownership is 40.67 years, the median is 28 years, and the range is 1-250 years. The middle fifty percent of respondents have owned their land between 15 and 57 years.

RESIDENCE (Q2)

Half of respondents reside on their wooded property, 18.34% live near their wooded property (less than 30 miles away) and 31.66% of respondents have their primary residence far from their wooded property. On average, people who don't live on their wooded property visit 35 times a year, but most visit less; the median number of annual visits is 12 and the middle fifty percent visit 4 to 30 times per year.

Of those who live away but under 30 miles from their woods, the median number of annual visits is 50, and the middle fifty percent visit between 20 and 120 times per year. For those who live more than 30 miles away, the median number of annual visits is nine, and the middle fifty percent visit between three and 20 times per year.


For those who do not live on their wooded land, 48.09% have a vacation home or cabin on their wooded land and 51.91% do not.

REASONS FOR OWNERSHIP (Q4)

The most important factor when it comes to respondents' wooded land is to enjoy beauty or scenery, with 69% of respondents rating it as very important and an additional 23% rating it as important. The next most important factor was to protect natural habitats for a variety of plants and animals, with 64% rating it as very important and an additional 24% rating it as important.

The least important factor is selling non-timber forest products; only 2% rate it as very important or important; the majority rate it as of little importance (29%) or not at all important (59%). The second least important factor is for selling timber products. Again, the majority rate it as of little importance (25%) or not important (33%), 23% rate it as moderately important, 11% as important, and 7% as very important.





PERCENT OF LANDOWNERS WHO ANSWERED VERY IMPORTANT OR IMPORTANT




PARTICIPATION IN LANDOWNER PROGRAMS/GROUPS (QS)

Approximately half (50.58%) of respondents participate in at least one of the listed landowner programs, and the other 49.42% do not participate in any (or do not know). The most highly participated-in program is Woodland Assessment Program (aka Tax Plan) with 26.65% of respondents participating, followed by the Agricultural Assessment Program at 18.79% participation, then Maryland Woodland Stewards, at 16.14% participation. The least participated-in program is state cost share programs (other than NRCS or Soil Conservation District) at only 3.34% participation, followed by conservation easement at only 3.63% participation.



FOREST MANAGEMENT PLANS (Q6)

Nearly half of all respondents (46.75%) have a Forest Management Plan, 50% do not, and 3.25% are not sure. Of those who have a forest management plan, the majority (68.63%) were written by a Maryland DNR Forest Service forester. Private consultant foresters wrote 16.99% of plans, industry foresters wrote 7.19%, the landowners wrote their own plans 5.88% of the time, and 1.31% of landowners were not sure who wrote their plan.



INCOME-GENERATING LAND USE (Q7)

AGRICULTURE

Approximately 32% of respondents farm or lease their land to others for agricultural production and 68% do not. Of those who do farm or lease their land for farming, the middle fifty percent have about 10-49 acres in agricultural production.

HUNTING LEASES

Only 2.42% of respondents lease their land to others for hunting, and those who do lease an average of 87% of their total land.

TIMBER HARVEST

Nearly half (44.74%) of respondents have ever harvested timber on their land. Of those, 38% harvested in the last ten years, 36% harvested between 10 to 20 years ago, and 27% harvested over 20 years ago.

LANDOWNER GOALS (Q8)

The survey asked landowners about their goals and desires for what they want to get out of their land through a series of agree/disagree statements. The most-commonly reported desire was to improve habitat for game species like deer and turkey, with 82% of respondents agreeing or strongly agreeing. The next most common goal was to protect rare plants or animals and unique habitats that might be on their land, with 70% agreeing or strongly agreeing. The least most common goal was to make money by selling wood products; only 28% agreed or strongly agreed with this statement.

COORDINATION WITH NEIGHBORS (Q8)

Most respondents (35.2%) are indifferent about whether they talk to their neighbors about land management. Approximately 30% agree or strongly agree that they do talk to their neighbors about land management, while another 29% disagree or strongly disagree. The remaining 6% are not sure.

Even fewer respondents coordinate land management activities such as boundary marking, invasive species control, or timber harvesting with their neighbors. About one quarter {25.62%} of respondents agree or strongly agree that they coordinate land management with their neighbors, while 29.3% are indifferent, 37.65% disagree, and 7.4% are not sure.

LANDOWNER PROPENSITY FOR ACTIVITIES (Q9)

Leaving out the landowners who selected "N/A", the most common activity that landowners have done recently is to leave some dead and dying wood standing for food and nesting habitat (33% have done this recently, and an additional 3% have plans to do soon, and only 5% would not do this). The next most common activity that landowners have done recently is to remove invasive plants (20% have done recently, 6% have plans to do soon, and 9% would not do this).

The most common activity that landowners "probably would do" (representing high landowner interest in the activity but not a lot of prior action or plans to do) is to avoid timber harvesting and/or road construction in unique habitats (59% probably would do), followed by restore and maintain forest along streams that pass through my land (58% probably would do). The other two "avoidance" activities also ranked highly in this category (limit construction of roads to avoid breakingup habitat and avoid timber harvesting and/or road construction during breeding season), at 56% of people saying they probably would do them.

The activities people are *least* likely to do include have a professional inventory their land for rare plants and animals (34% would not do), have a professional map wildlife features on their land (32% would not do), and attend a workshop or training (31% would not do). It is interesting to note, however, is that 36% of people might attend a workshop or training and 27% of people probably would attend one, while only 6% of people have attended one or

plan to in the near future. This suggests that there may be significant interest in workshops but that they are not currently offered (or not currently marketed well).

BARRIERS/CHALLENGES (QIO)

The largest barrier in caring for land to support wildlife is that the cost of implementing practices is too high; about 39% of respondents agree that this is a challenge. About 22% of respondents don't know whether the cost of


implementing these practices is too high, and an additional 24% are indifferent about cost as a challenge, suggesting a high lack of awareness around how much these practices may cost.

The second and third highest barriers are around knowledge/confidence. Approximately 37% of respondents are unsure about the activities they should do, and 31% are concerned about doing the wrong thing and harming their land.

In general, landowners do not seem to view finding contractors as a challenge they face in caring for their land to support wildlife; only 10% of respondents view this as a barrier. However, this data point could also suggest that people haven't wanted to hire contractors. In addition, most people do not believe that undertaking activities would change the appearance of their land too much (or do not view it as a challenge); only 14% view that as a challenge they face in caring for their land to support wildlife.

In the graph below, the barriers are ranked by% of respondents who agreed or strongly agreed with each statement (indicating a high barrier for more people).

TRUST (QII)

In general, landowners seem to trust state, university, and federal organizations the most, followed by non-profit organizations, then for-profit and other individuals.


Respondents most highly trust state forestry professionals (MD DNR Forest Service) to provide information on caring for their wooded land; over three-quarters {78%} trust or highly trust them. Even among for the respondents who

do not have a forest management plan written by MD DNR, 72% trust or highly trust them. State wildlife professionals (MD DNR Wildlife & Heritage Service) are also highly trusted, with 72% of respondents trusting or highly trusting them. On average, respondents trust these two groups more than even their own personal experience (69% of respondents trust or highly trust their own experience).

Hunt clubs were the least-trusted group, with 39% of respondents not trusting them. The internet (31% do not trust) and loggers (35% do not trust) also received low trust ratings.

Many landowners were unsure about whether they would trust local watershed groups (33% don't know if they would trust) and bird or naturalist clubs (30% don't know).




What is your gender?


What is your age range?




How many people live in your household?





Do members of your household visit parks or recreation areas in Allegany County? 331 responses




How would you describe your activity level? 331 responses






Do you feel there an unmet demand for outdoor recreation in Allegany County? 331 responses




If members of your household do not visit parks or recreation areas in Allegany County, what are the reasons? (Please select all that apply.)








Proximity to Parks




Proximity to Natural Areas




Proximity to Picnic Facilities




Proximity to Water Access









Appendix L - Rural Legacy Map
