THE MARYLAND WILDLIFE ADVISORY COMMISSION MINUTES FEBRUARY 21, 2024

Chair Wagner called the meeting to order at 10:30 a.m. This meeting was held via teleconference. Chair Wagner asked for a roll call of individuals on the "call." Unfortunately, because of the anonymity of Google Meet callers, it was impossible to determine the identity of every participant.

Approval for February 21, 2024, Meeting Agenda

- Motion to Approve the Agenda:
 - 1. Commissioner Schroyer moved to accept the Commission Meeting Agenda for February 21, 2024.
 - 2. Commissioner Keithley seconded.
 - 3. All in favor. Motion passed.

Approval for Minutes from January 17, 2024, Meeting

- Motion:
 - 1. Commissioner Keithley moved to accept the January 17, 2024, Meeting Minutes.
 - 2. Commissioner Cole seconded.
 - 3. All in favor. Motion passed.

2024-2026 Hunting Regulation Concepts Update – Karina Stonesifer, Director

- Director Karina Stonesifer mentioned to the Commission that the proposals were posted online and will remain online through February 26, 2024.
- Staff are reviewing the comments as they come in. Once the comments are reviewed, staff will present a summary of the comments for final recommendations to the Commission on March 20, 2024. The Commission will vote on the final recommendations at the March 20, 2024, meeting.
- Staff members do not edit comments, but staff must remove any private information.
- O&A Section:
 - 1. Commissioner Keithley asked if the blood-tracking dog regulations were in the proposals submitted for comment.
 - a. Director Stonesifer replied, "No."
 - b. Reviewing the current regulations and tightening the tracking regulations is not a heavy lift. Staff recognized the need to convene a modified stakeholder group to examine these regulations for changes.
 - 2. Ms. Lindsay Thompson from the public wrote a question in the chat. Ms. Thompson asked if there would be any in-person sessions this year.
 - a. Director Stonesifer responded, "No," but the public may provide comments online. Staff decided to go with the online system due to the lack of attendance at the in-person meetings. Staff accept comments online, by fax, mail, and telephone.
 - 3. Commissioner Showalter mentioned receiving many comments on the waterfowl seasons and asked if the Commission would discuss these seasons at the March 20 meeting.
 - a. Director Stonesifer mentioned that discussions typically occur during the final recommendations of the proposals for the Commission voting process.
 - b. Director Stonesifer recognized that the public had been very vocal about the 30-day and two-bird bag limit during the Canada goose season compared to the 45-day and one-bird bag limit. Staff presented what the federal government allows; staff cannot go any longer than the 30-day limit.
 - c. Chair Wagner reiterated that Maryland could have a 30-day and one bird bag limit, but Maryland cannot have a 45-day and one bird bag limit because 45 days is outside of the

federal framework. Maryland is allowed to have less but not more than the federal frameworks.

- 4. Commissioner Showalter asked if staff would implement the Sunday dates for the 2024-2025 hunting season if the Sunday hunting bill passes.
 - a. Yes, the Sunday hunting dates will be implemented for the 2024-2025 season.
 - b. Staff have changed regulations due to Sunday hunting bills passing through. Staff have had discussions with the federal government, and the federal government agreed to work with staff on Sunday hunting. Therefore, staff will work with the federal government to implement the Sunday dates into the 2024-2025 season.
- 5. Commissioner Showalter asked about the January season split. It starts and ends on weekdays, January 14, 2025 January 31, 2025. If the federal government permits it, why not start it a day later, including another weekend, and pick up a third Saturday on February 1, 2025?
 - a. These are legitimate comments that staff could accommodate under the federal framework. Remember that staff cannot accommodate the 45-day due to the 30-day federal framework that has been set.
 - b. When Maryland was in the last restrictive package five years ago, staff received much public comment and took a hard look at things. Staff decided that with the 30-day restrictive package, Maryland would overlap the goose season with those 30 days during the duck season. Again, it was because the most common comments received during that time were that hunters like duck and goose season to overlap as much as possible.
 - c. Staff could accommodate starting the January date later, but the downside would be that hunters will not have the duck and goose overlap.

2024 Legislative Session Update – Brian Eyler, Associate Director

• Associate Director Eyler mentioned that he listed bills on the Summary of 2024 Proposed Legislation as of February 20, 2024. All the Senate bills are cross-filed with House bills on the list.

- Motion to Oppose HB0430 Firearms Liability Insurance Public Wearing and Carrying:
 - 1. Vice Chair Schroyer moved to oppose HB0430 Firearms Liability Insurance Public Wearing and Carrying.
 - 2. Commissioner Jenkins seconded the motion.
 - 3. Motion passed with one abstention.
 - 4. Chair Wagner and Commissioner Showalter will collaborate to compile a letter from the Commission opposing HB0430.
- Motion to Oppose HB0590 and SB0924 Boating Migratory Waterfowl Season Prohibited Acts.
 - 1. Commissioner Showalter moved to oppose HB0590 and SB0924 Boating Migratory Waterfowl Season Prohibited Acts.
 - 2. Vice Chair Schrover seconded the motion.
 - 3. Motion passed with one abstention.
 - 4. Chair Wagner and Commissioner Showalter will collaborate to compile a letter from the Commission opposing HB0590 and SB0924.
- Discussion on HB1473 and SB0983 Hunting Lead and Lead–Based Ammunition Phase Out.
 - 1. Commissioner Kullberg noted that she supports the HB1473 and SB0983 bills.
 - 2. These types of bills passed in California a couple of years ago, and the U.S. Fish & Wildlife Service (USFWS)is moving to include all the significant refuges, including those in Maryland. They will be required to follow by September 2026. When the USFWS did this for migratory game birds, it was a federal initiative, and they did the training and outreach and worked with the

- manufacturers. However, each state decides this time, so it is a different model.
- 3. These bills require the Department to create a certification program.
- 4. Different studies relate to lead/lead-based vs. non-lead ammunition, but no apparent trend exists. It is easier to get weight and energy out of lead and lead-based ammunition.
- Motion to Oppose HB1473 and SB0983 Hunting Lead and Lead–Based Ammunition Phase Out.
 - 1. Commissioner Parks moved to oppose HB1473 and SB0983 Hunting—Lead and Lead-Based Ammunition—Phase Out. He outlined that we should give it another year since the bill was introduced last year; it will most likely come up again next year so that we can see what happens with the ammunition manufacturers to help make it a more palatable solution.
 - 2. Commissioner Keithley seconded the motion.
 - 3. Motion passed with one opposed.
 - 4. Chair Wagner and Commissioner Showalter will collaborate to compile a letter from the Commission opposing HB1473 and SB0983.
- Motion to Support HB1500 and SB0847 Dorchester County Sunday Hunting Repeal of Time Restriction.
 - 1. Commissioner Keithley moved to support HB1500 and SB0847 Dorchester County Sunday Hunting Repeal of Time Restriction.
 - 2. Commissioner Rossignuolo seconded the motion.
 - 3. Motion passed with one abstention.
 - 4. Chair Wagner and Commissioner Showalter will collaborate to compile a letter from the Commission supporting HB1500 and SB0847.
- Chair Wagner and Commissioner Showalter will email the Commission for their approval before sending the letters to the Committees.

Maryland Farm Bureau Update (MFB) – Parker Welch, Executive Director

- Executive Director Welch said he wanted to keep in touch with the Commission and staff because it has been some time since Mr. Coby Ferguson left.
- Traditionally, MFB Government Relation Director Tyler Hough will attend the Commission meetings. However, Mr. Hough was unable to attend.
- MFB is busy with the legislative session.

Natural Resources Police Update (NRP) – Captain Shawn Garren gave a presentation.

- As of February 2024, the total number of violations is 1,604.
- There were 451 wildlife violations, 192 boating violations, 165 public lands violations, 225 fisheries violations, and 568 traffic violations.
- The percentage per category is 12% boating, 35% traffic, 10% public lands, 28% wildlife, and 14% fisheries violations.
- A colonel was appointed to the Natural Resources Police; the person will start on April 17, 2024.
- Recruitment—NRP recently held a small class, and graduates are now doing field training. That is one reason traffic violations are high. The graduates are required to make 50 traffic stops per officer to obtain access to the e-ticket system. In the next month, these officers will have completed their field training.
- NRP is in a hiring freeze until the new colonel is onboard.

Old Business

• The Use of Drones for Deer Recovery was tabled until the next meeting. The Commission hopes staff will have more information at the March 20, 2024, meeting to help the Commission decide if the members need to move forward with regulations or guidelines for drone recovery.

New Business

• The Commission received a letter from a constituent about a bike trail at Piney Mountain and Big Savage Mountain. Chair Wagner requested that the Commission review the letter emailed to the

- Commission. Chair Wagner commented that he thinks the questions asked are outside the scope of the Commission. The members of the Commission agreed with Chair Wagner's input. Chair Wagner will contact the constituent directly.
- Commissioner Keithley asked Assistant Secretary Peditto about the status of the Wildlife and
 Heritage Service and the idea of designing some black bear tags for auction for some of the
 organizations in the state. Commissioner Keithly mentioned that he suggested this at the stakeholder's
 meeting. There appeared to be some issues with the concept of being legal in Maryland.
 Commissioner Keithley requested a direct answer on whether the Wildlife and Heritage Service can
 allocate a certain number of black bear tags to a Bowhunters Society of Maryland, for example.
 - 1. Assistant Secretary Peditto responded that if the outcome is that the organization is doing the auction and receives any of the proceeds from that effort, the Wildlife and Heritage Service would need specific statutory authority. It is not unlike what happened with the lifetime hunting license, going back to about 15 years ago, when the legislature laid out a plan for x number of licenses and who got what in terms of the proceeds.
 - 2. Assistant Secretary Peditto added that the Wildlife and Heritage Service may have authority on most issues in the Natural Resources Article. However, the legislature retains the authority for setting fees, and this suggestion would fall under that authority.
 - 3. Commissioner Keithley emphasized that donating black bear tags would encourage organizations to work together and build a closer relationship with the Wildlife and Heritage Service.
 - 4. Commissioner Showalter mentioned other states with governor's tags or other donations, which allow the organizations to keep 10%, and 90% is allocated to the state. Commissioner Showalter questioned whether it is worth the effort in Maryland for a few black bear tags to go through the legislature process.
 - 5. Commissioner Keithley acknowledged Commissioner Showalter's comments but agreed that donating black bear tags could go a long way in bridging the gap between some of the hunting organizations and the Department. On the legislative side, Commissioner Keithley could work with Hunters of Maryland LLC on this project and with many others to introduce a bill. Commissioner Keithley recognized that it would not generate much money but create other intangibles.
- Commissioner Showalter requested a License Portal Update at the March 20, 2024, meeting.
