THE MARYLAND WILDLIFE ADVISORY COMMISSION MINUTES – AUGUST 19, 2020

Vice Chair Gregor called the meeting to order at 10:36 a.m. This meeting was held via teleconference and videoconference. Vice Chair Gregor asked for roll call of individuals who were on the "call". Because of the anonymity of Google Meet telephone participants, it was impossible to determine the identity of every participant.

Approval for August 19, 2020 Meeting Agenda

- Motion:
 - 1. Commissioner Michael moved to accept the August 19, 2020 Wildlife Advisory Commission Meeting Agenda.
 - 2. Commissioner Gulbrandsen seconded.
 - 3. All in favor. Motion passed.

Approval for Minutes from June 17, 2020 Meeting

- Motion:
 - 1. Commissioner Keithley moved to accept the June 17, 2020 meeting minutes as presented.
 - 2. Commissioner Schroyer seconded.
 - 3. All in favor. Motion passed.

Information and Education Program Update – Presentation was given by Information and Education Manager (I&E) Nancy Doran.

- Ms. Doran provided a summary of the Annual I&E Program in a Power Point Presentation. [ATTACHMENT A]
- Despite the restrictions COVID-19 has caused, I&E Program staff have been very busy.
- 'Making the Link' is a new project that Outreach and Education Specialist Kerry Wixted and other partners are working on. Maryland public schools are required to provide Meaningful Watershed Environmental Education Experiences for students per the Chesapeake Bay Agreement. It will encompass 10 weeks of learning.
- Kerry Wixted was awarded the 2019 Outreach Educator of the Year award.
- Several members of the Commission applauded I&E staff for their work during COVID-19.

Natural Heritage Program Update – Presentation was given by Associate Director Jonathan McKnight.

- Associate Director McKnight outlined the budget situation the Natural Heritage Program (NHP) is facing. The two funding sources are the Chesapeake Bay Tax Check-Off and State Wildlife Grants. The former is from state tax return check-off and license plate sales MD DNR-NHP receives a portion of each. The latter is a reimbursable grant from the USFWS. Unfortunately, both funding sources are low for FY21. There is an approximate 20% decline in both fund sources and this is expected to get worse.
- The NHP is down three positions. Two of the positions were approved prior to COVID-19. Since COVID-19, staff have not seen any movement related to positions.
- Due to the nature of the work that staff do, there is a significant amount of field work that has been foreclosed.
- Restoration work was held up due to COVID-19. However, a few staff members were able to do
 some invasive control restoration work on varies natural areas. Staff have been unable to do
 controlled burns because of COVID-19 due to personnel and equipment requirement. Staff are only
 allowed to have one person in a vehicle.
- Environmental Reviews have been maintained during COVID-19 within the maximum 30-day turnaround time.
- As people stay home, staff have seen uptick of public inquiries related to identification of non-game

species. One of the items staff noted an increase in is the reporting of seeing nutria but staff have not received confirmation these reported sightings are actually nutria. Nutria have been eradicated on the Eastern Shore. Staff are about to close down the Eastern Shore Eradication Program. There is new nutria development that has jumped from south of James River to Chickahominy River, which brings it closer to the York River and Rappahannock River along with the Potomac River. Staff are working with Virginia to avoid nutria hitting these areas.

Wildlife Diversity Advisory Committee Update – Presentation was given by Associate Director Jonathan McKnight.

- The members of the Wildlife Diversity Advisory Committee have not met since last summer.
- The Wildlife Diversity Advisory Committee is down to four members. These four members are very active in keeping with the mission of the Committee. Staff are working with the Administration to attain more members on the Committee.
- Every year, the members review the expenditures of Maryland's State Wildlife Grant money. The four members were able to complete the review.
- The individual members have been actively involved in getting support through Congress relating to the Recovery of America's Wildlife Act, which the Commission provided a letter of support for some time ago. The Act passed the House and is awaiting action in the U.S. Senate.

Farmer of the Year Award Criteria Update – Presentation was given by Commissioner Eric Gulbrandsen.

- The Commission received an email copy of the Proposed Farmer of the Year Award Criteria. [ATTACHMENT B]
- Commissioner Gulbrandsen gave a summary of the proposed criteria.
- On page 1 under 4. (e), the words "planting less desirable forage crops along edges" will be replaced with "diversionary crops".
- Commissioner Gulbrandsen asked Director Peditto about 4 (g) relating to farm cooperating with MD DNR to provide hunting opportunities to the general public.
 - 1. Director Peditto indicated the Commission could make it a criteria but it will probably reduce the amount of nominees for the award.
 - 2. Commissioner Gulbrandsen indicated a farmer does not have to meet all the criteria listed.
- The Commission supported the Proposed Farmer of the Year Award Criteria.
- Commissioner Gulbrandsen will make the few changes and create a form for a formal vote at the September WAC meeting before it gets distributed to the Maryland Farm Bureau.
- The Farmer of the Year is normally presented at the Annual Maryland Farm Bureau Convention, which is held in December. This year it will be done virtually.

Natural Resources Police Update – Presentation was given by Lieutenant Charles Fawley.

- Outdoor Hunter Safety Courses have resumed. There were around 450 applicants for these courses with many more to come.
- Natural Resources Police (NRP) budget has been cut by \$1.3 million and will primarily impact vehicles for NRP. The aviation unit has also been suspended for the foreseeable future.
- There has been a COVID-19 exposure at the Academy. The Academy has been suspended.
- Lt. Charles Fawley shared screen of the NRP July 2020 Statewide Stats. The Commissioners received an electronic copy of the July 2020 Statewide Stats. [ATTACHMENT C]
- Commissioner Gulbrandsen asked for a list of counties covered in the NRP areas. Commissioner Michael sent the link to the Commissioners of the list of areas.

Maryland Farm Bureau Update – Presentation given by Director of Government & Public Relations Colby Ferguson.

• Mr. Ferguson indicated that the MFB held a wildlife meeting in late July. The MFB is in the middle of policy developments. Most of the crop damage reported is due to deer.

- In Somerset County, MFB has started a program to harvest more does.
- MFB looking for ways to promote hunting on farm lands ways to promote hunting in which PR funds can be used.
- Baltimore County wants to get rid of their groundhog issues.
- Director Peditto asked Mr. Ferguson about the MFB interest in a case that came out of Court of Special Appeals in April relating to the Recreational Use Statue a farmer in western MD held an outdoor day for friends from his church and one of the members that were invited crashed an ATV. The person is now a quadriplegic. The person sued and the Court held that the Recreational Use Statue only applies if someone opens his or her property to the entire public. The ruling is pretty significant for individuals opening their lands up to hunting.
 - 1. Discussion ensued about the impacts to landowners and suggestions for correcting the situation.
 - 2. Mr. Ferguson may seek Commissioner Weinberg's assistance.
 - 3. Commissioner Michael sent Mr. Ferguson the link to the case. There are other issues with this ruling.

Old Business - No Old Business.

New Business

- Straight-Walled Cartridges on WMAs Discussion.
 - 1. The new Straight-Walled Cartridges regulations went into effect on August 10.
 - 2. Associate Director Timothy Larney outlined some housekeeping regulations related to straight-walled cartridges on some Wildlife Management Areas (WMA) restricting the usage of them according to regulations and address the areas that are archery only for deer. The proposed straight-walled cartridges usage on WMA regulations will make it consistent with the other WMAs that allow the use of straight-walled cartridges. In summary, the proposed language under 08.03.02.28 will change to allow straight-walled cartridges on all WMAs.
 - 3. Discussion ensued about the potential changes to prevent a hunter from getting tripped up by using a straight-walled rifles/cartridges and getting the proposed changes to the Commission in writing.

Motion:

1. Commissioner Michael moved to support the change to allow straight-walled rifles/cartridges on those WMAs that are currently prohibited.

2. Discussion:

- a. Commissioner Boyles Griffin expressed before moving forward, commented that the Commission should have the changes in writing. Commissioner Boyles Griffin did not understand why that was done this time around.
- b. Director Peditto explained that after the straight-walled regulations were approved, the managed hunt managers were going through WMAs regulations to allow this new tool for hunters on WMAs and found out there are areas in WMA regulations that prohibit the use of straight-walled cartridges on some WMAs. Staff needs to clean this up in the regulations so that hunters are not cited for being inconsistent with the new regulations that have been thoroughly vetted. There are only a handful of WMAs implicated.
- c. Staff are asking the Commission for support to move forward with draft regulations to address this issue.
- d. Commissioner Michael sent the regulations link to the Commission during the discussion.
- e. Staff agreed to send the proposed changes to the Commission.
- 3. Commissioner Gulbrandsen expressed unless Commissioner Michael wants to amend his motion; Commissioner Gulbrandsen seconded it.
- 4. Commissioner Michael indicated that he was fine.
- 5. Motion passed with one abstained.

- 6. Vice-Chair Gregor indicated the Commission will see the proposed changes at another meeting.
- September 16, 2020 Field Day is postponed due to COVID.
- Motion:
 - 1. Commissioner Schroyer moved to have a September 16, 2020 Wildlife Advisory Commission Meeting via Google Meet to consider the proposed straight-walled regulations and any other business.
 - 2. Commissioner Michael seconded.
 - 3. All in flavor. Motion passed
 - 4. The Wildlife Advisory Commission members decided to have September 16, 2020 meeting via Google Meet instead of a field day.
- DNR App Commissioner Schroyer mentioned to staff that the DNR App stills has the 2019-2020 hunting season dates.
 - 1. Associate Director Stonesifer outlined that IT had some turnover. DoIT and the vendor are working on getting the DNR App updated with the 2020-2021 hunting season dates. Staff members are aware of the situation.
- Virtual Offshore Blind Site Licensing
 - 1. Director Peditto reminded the Commission that the Department will be responsible for issuing offshore blind site licensing starting the first Tuesday in August by law, which involved 1000s of licenses being issued to the public by our staff. Historically, it involved 40 to 50 staff, many NRP officers, rented printers and a large venue where 100s of hunters with dozens of our staff to select sites offshore in tidal counties for waterfowl hunting.
 - 2. There was no mechanism under the Governor's Executive Order to gather those people and make issuances of the offshore blind site licensing happen. Staff received permission to move forward on July 2 to go virtual for offshore blind site licensing. In a matter of a five-week window, staff were able to transition the process to virtual licensing issuance program. The first day was in midst of a hurricane with power outages. There was no physical contact.
 - 3. On August 19, 2020, staff were in the next phase of opening it up to others not part of the lottery process.
 - 4. Director Peditto thanked Karina Stonesifer and a small team that included: Bill Harvey, Josh Homyack, Lynn Davidson, Tina Jarvis and Tim D'Adamo from IT for their efforts to pull this off. This new process is saving us a lot of money. The program will become more efficient as time goes on.

Virtual Outdoor Learning

- 1. Commissioner Michael mentioned being in the midst of the pandemic and hearing about recruitment from Lt. Fawley and recreational use on state lands are up. Commissioner Michael would think that the number of hunters in the field is going to grow. Commissioner Michael threw it out there what we can do to capitalize on this increased opportunity for hunting retention and recruitment. Commissioner Michael outlined what he was going to do. The Wildlife and Heritage Service should put some public information out there that now is the time to go back to our hunting heritage since we cannot do anything else.
- 2. Associate Director Stonesifer expressed that Commissioner Michael's comments are right on target. Associate Director Stonesifer mentioned staff were planning on rolling out the mentor hunt program this fall, which initially called for a mentor take out a mentee in close contact and teach them how to hunt. Staff realized that was not going to occur, and decided to revamp the program. Staff are in the process of releasing new information with the thought of still encouraging various hunters to become a mentor and to reach out to the mentee to start that relationship online, similar to what we are doing here. During this period, it is a great opportunity to take advantage of individuals being at home.
- 3. There was also a discussion about hunter safety and how a person is expected to complete the requirements given the increased demand and fewer field days. The Commission discussed the

fact that several states have eliminated or modified the live fire provision in the hunter education programs due to inability to have groups of people in a location. These states have seen an increase of number of people eligible to buy hunting licenses by doing the virtual training or in person training not requiring a live fire mandate. It is something to think about in terms of recruitment. Director Peditto asked the Commission to help the Wildlife and Heritage Service navigate that dialogue since Maryland has seen also an increase of individuals that want to hunt. LT. Fawley mentioned that the Live Fire Provision is a policy not regulatory.







Maryland Wildlife Advisory Commission Proposed Farmer of the Year Award Criteria (Draft)

- 1) If WAC is to continue awarding this award it needs to be within the scope of our mission.
 - a. Taken from the text of Natural Resources Article subsection 1-102©(2)(ii) The Governor shall solicit fpr vacancies on the Wildlife Advisory Commission from individuals or organizations that promote the future of hunting and individuals or organizations that promote the preservation of wildlife in the State, with geographical distribution being a prime consideration for filling vacancies.
- In consideration of above we recommend that our award criteria be focused primarily on the future of hunting and the preservation of wildlife in Maryland.
- 3) While some members may have expertise in agricultural practices, soil and water conservation, pollution control or any of the other areas involved in managing a farm that would qualify as "award worthy", our collective experience lies in the matters involving the hunting and preservation of wildlife here in MD.
- We recommend that the following criteria be considered as the PRIMARY considerations for awarding the referenced award;
 - a. Provide a brief description of your farming operation.
 - b. Does the farm promote hunting in Maryland and if so how? (example allows hunting on farm)
 - c. Does the farm promote the preservation of wildlife in Maryland and if so how? (example encourages practices to sustainably harvest game animals to ensure a viable population of game for future generations.)
 - d. What practices does the farm utilize to provide supplemental feed and habitat for wildlife? (i.e. cover crops, habitat buffers, etc.)
 - e. What practices does the farm utilize to limit crop damage by wildlife? (i.e. trapping, planting less desirable forage crops along edges, fencing where

- practical, non-lethal methods, or other creative methods.)
- f. Does the farm support youth, wounded warrior and other mentored hunting efforts?
- g. Does the farm cooperate with MD DNR to provide hunting opportunities to the general public? (ask Paul about this)
- h. How does the farm manage hunting access? Does the farm allow hunting by general public, lease to a hunt club, or limited to friends and family only?
